within the project**

**“In search of the neuropsychophysiological underpinnings of impaired figurative language
comprehension in schizophrenia: on the role of the salience gradability of meanings - behavioral, EEG,
and MRI study”**

funded by National Science Center, OPUS 21 (UMO-2021/41/B/HS6/02967 ; PSP K/PBO/000868)

According to the article 3.3 of Regulations for awarding NCN scholarships for NCN-funded research projects, the scholarship may be awarded to a person who meets any of the following criteria: is a student of a full-time first or second-cycle degree programme or uniform Master’s studies at a university in Poland; is a participant in a doctoral programme; is a doctoral candidate at a doctoral school.

We invite to apply:

- students of uniform Master’s studies (at least the fourth year of study) or students of the second-cycle degree programme (in the field of psychology or related sciences),
- participants in a doctoral programme,
- doctoral candidates at a doctoral school,
- individuals interested in participation at a doctoral school.

Additional attributes:

- interest in neuroscience oriented clinical psychology, neuropsychology, psychophysiology or neuroimaging,
- interest in the role of language, communication, cognitive impairments in the psychopathology in schizophrenia,
- earlier experience in scientific project realization, e.g. participation as co-worker,
- openness for work with psychiatric patients with schizophrenia,
- familiarity with statistical software and statistical data analysis, (e.g. Matlab, Python, SPM, SPSS/Statistica),
- earlier experience in neuroimaging (EEG or fMRI) data analysis (e.g. FSL, FreeSurfer, EEGLab, Emegs, Multar);
- fluency in written and spoken English.

According to the article 3.12 of Regulations for awarding NCN scholarships for NCN-funded research projects **following criteria are considered:**

- the candidate’s research achievements, including publications in prestigious academic press /journals (50% of the final score),

- research-related achievements, scholarships, awards and research experience gained in Poland or abroad, research workshops and training courses, participation in research projects (20% of the final score),
- the candidate's competence to carry out specific tasks in the research project (30% of the final score).

Duties include:

- literature research and active participation in the theoretical concept of research design,
- preparation of the study materials,
- programming and implementation of the research procedures,
- conducting the experiments in the laboratory,
- back-up and entering the data from the experiments to the statistical software,
- conducting the statistical analysis,
- interpretation of the results,
- preparation of the publications and the conference presentations,
- presentation of the results at the scientific conferences,
- attendance in the regular research team meetings,
- time flexibility – on-site work at the Institute of Psychology of the Jagiellonian University or Clinical Hospital, or EEG/MRI laboratory for about 8 hours per day from Monday to Friday. Short term remote work is possible. Working hours will be determined considering schedule of the classes of the applicant.

We offer:

- scholarship, 3000 PLN per month, for 36 months,
- open space desk,
- employment in the dynamically developing Research Team,
- opportunity for scientific development and improvement of the research skills,
- co-authoring of the new publications created by the Research Team,
- opportunity to participate in Polish and international conferences,
- opportunity to implement own research projects in cooperation with the members of the Research Team.

6. letter of recommendation in English,

Selected candidates will be invited to an interview in English that would be held on: January 2023 after individual arrangement.

Personal data processing information for job applicants

3. Your personal data will be processed in order to:
 - a. conduct recruitment process for the position specified in this advertisement – as part of the legal obligation of the Administrator pursuant to Art. 6 (1) lit c of the GDPR in connection with the Polish Labour Code;
 - b. conduct recruitment process for the position specified in this advertisement based on your consent pursuant to Art. 6 (1) lit a of the GDPR – your consent is granted by the clear action of submitting your CV with the Administrator. The consent to the processing of personal data concerns data that you voluntarily provide as part of your CV, which do not result from Polish Labour Code.
4. The obligation to provide your personal data results from the law (it applies to personal data processed under Article 6 (1) lit c of the GDPR). Failure to provide your personal data will result in your inability to take part in the recruitment process. Submission of personal data processed on the basis of consent (Article 6 (1) lit a of the GDPR) is voluntary.
5. Your data will be processed during the recruitment period. In the event of not concluding the contract with you, your data will be deleted after the recruitment process.
